The 2023 year was a fruitful one for our organization, with many successes and new developments that have seen the CAPG grow. Here are just a few of our accomplishments in 2024:

- We hosted 'Governance Talking' our 34<sup>th</sup> annual conference in St. John's, NL in August. This was a great success, with a large number expert of panelists, researchers, and sharing best practices and insights as to where police governance is going.
- Our monthly webinars provided a wide range of topics directly addressing many of the key issues and challenges facing police governance today. Look for some exciting changes in the 2024 line up to be released later in January.
- CAPG reinstated the annual joint meeting of the three national police associations, Canadian Police Association (CPA), the Canadian Association of Police Chiefs (CACP) and CAPG. This meeting was held in Vancouver in January and the items for discussion included *Bail Reform, Line of Duty Deaths, Psychologically Healthy Work Places, and Recruitment & Retention*.
- CAPG with CPA cohosted a one-day summit on Leadership in Policing that brought a good collection of police leaders, governors, and association representatives to the table to take some hard looks at diversity, measuring competencies, leadership training and who evaluates the effectiveness and appropriateness of this investment.
- Our First Nations Police Governance Council (FNPGC) continued to work on their engagement of FN Police governance authorities across the country on the co-development of legislation to move the FNIPP from a program to an essential service and what that means for governance.
- CAPG continues to actively participate in Canadian Institute Public Safety Research & Treatment (CIPSRT) with representation on their Public Safety Steering Committee (PSSC). The work that CIPSRT is doing across the country is worth checking out on their website. <https://www.cipsrt-icrtsp.ca/>
- CAPG and Public Safety Canada is continually building on the strong relationships we have with senior bureaucrats and the Minister's office.

We are looking forward to the next Annual Conference and AGM taking place in Halifax, Nova Scotia this coming August. As public safety in many provinces is in the process of some significant modernizing changes in relation to police governance, we will be focusing the Annual Conference on the issues that will reflect what you and your organizations need to know and what directly impacts your organization.

We are very much looking forward to designing and implementing a national CAPG training program with accreditation, a program that reflects the unique differences of each jurisdiction and the ongoing modernization of policing within Canada.

Members will receive 50% off an expanding number of planned webinars in 2024 and discounts on governance summits, as well as priority registration. We are continually updating the CAPG Learning Portal, our searchable library of many key research papers, reports and presentations on our website that is responsive to keyword searches.
